The Government of the Republic of Moldova has applied for financing in the amount of US\$ 80 million equivalent from the World Bank toward the cost of the Local Roads Improvement Project and it intends to apply

part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project.

The project will include the following components:

Component A: Rehabilitation and Maintenance of Local Road Network:

Aimed at financing the rehabilitation and upgrading of about 300 km of Local Roads. The works will be carried out in phases during about five years of project life.

1st Phase Roads, comprising Road C8 (Cornesti – M14 – Radeni – Hirbovat – R21) totalling approximately 44.2 km, will be procured in Q1 of 2016.

Component B: Institutional Strengthening:

Aimed at the reform of local roads management in Moldova and strengthening the capacity to manage the local road network. Several consultancy services of varying size are planned for the implementation of the project including:

1. Project Management and Institutional Strengthening consultant
2. Engineering design consultants
3. Construction supervision consultants
4. Technical audit consultants

Consultancy services for engineering design will be financed from the Moldova national budget in accordance with Moldova national procurement procedures.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers* (current edition), and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the World Bank's *Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits and Grants by World Bank Borrowers* (current edition).

Procurement of the following services will commence in Q1 of 2016:

1. Project Management and Institutional Strengthening consultant
2. Engineering design consultants
3. Construction supervision consultants

Specific procurement notices for contracts to be bid under the World Bank's international competitive bidding (ICB) procedures and for contracts for consultancy services will be announced, as they become available, in [UN Development Business](#) and in the Moldova State Road Administration's website ([ASD.MD](#)) and in local newspapers (for national competitive bidding procedures).
