



## MINUTES OF PUBLIC FINANCIAL PROPOSAL OPENING

**Tender No. # PP3/RRP/CS/QCBS/08/01 and # PP3/RRP/CS/QCBS/08/02**

**Date: April 3, 2012**

### **Introduction**

1. The public financial proposal opening for the procurement of:
  - **Lot 1** - Construction Supervision of 2 No. Civil Works Contracts for Rehabilitation of Road M2 Chişinău – Soroca km 71+194 – km 116+000 (tender # PP3/RRP/CS/QCBS/08/01);
  - **Lot 2** - Construction Supervision of 2 No. Civil Works Contracts for Rehabilitation of Road M2 Chişinău – Soroca km 116+000 – km 154+352 and Road R7 Soroca-Drochia-Costesti km 3+414 – km 12+789 (tender #PP3/RRP/CS/QCBS/08/02),

took place at 10:30 am local time in Moldova on April 3, 2012 in room No.400, 4<sup>th</sup> floor within the premises of State Road Administration – Procurement Agent for MCA – Moldova Road Rehabilitation Project at Bucuriei 12A street, Chişinău, Republic of Moldova.

3. Representatives of four (4) consultants were present (refer to Annex 1. Register of Attendance).

### Proceedings

4. All sealed envelopes with financial proposals were placed in the room and were visible to all attendees until the end of the procedure. The financial proposal opening procedure started at 10:30 am local time in Moldova. The SRA-Procurement Agent in the presence of MCA - Moldova and consultants' representatives opened the envelopes of financial proposals, one at a time in accordance with their order of submission. The SRA-Procurement Agent filled in the Financial Proposal Opening Checklists for each consultant (Annex 2. Bid Opening Checklists) and recorded the read aloud technical scores and financial proposal prices (Annex 3. Register of Financial Proposal Prices). Each consultant's authorized representative was requested to sign in its Financial Proposal Opening Checklist and the Register of Financial Proposal Prices.

As a result of evaluation of technical proposals, the mentioned companies accumulated the minimum qualifying score of 80 points of 100 possible:

- a. *Search Corporation Srl (Romania) in consortium with Aecom Inginieria Srl (Romania) - only for Lot 1;*
- b. *URS Infrastructure & Environment UK Limited (United Kingdom) - for Lot 1 and Lot 2;*
- c. *Egis International (France) - for Lot 1 and Lot 2;*
- d. *IRD Engineering Srl (Italy) - for Lot 1 and Lot 2;*
- e. *WSP Group Srl (Romania) in association with Salfo & Associates SA (Greece) and Technic Romania Srl (Romania) - for Lot 1 and Lot 2;*
- f. *Louis Berger SAS (France) – for Lot 1 and lot 2.*

The no – objection memorandum for Technical Evaluation Report was issued by the Millennium Challenge Corporation on March 23, 2012.

The Invitation for attendance of Public Financial Proposals opening session was to the companies on March 29, 2012.


7. The financial proposal opening procedure was finalized at 11:15 am local time in Moldova on April 3, 2012.
