This Amendment is to make certain changes and additions to the Request for Proposals documents no CS/QCBS/01-02/2014 issued on September 08, 2014.

A. Instructions to Consultants, Data Sheet:

- 1. *Reference* to sub-clause 16.1 shall be substituted to clause 16.
- 2. Reference to sub-clause 16.2 shall be substituted to 16.1.
- 3. *Reference* to sub-clause 16.3 shall be substituted to 16.2.
- 4. Reference to sub-clause 16.4 shall be substituted to 16.3.
- 5. Reference to sub-clause 27.1 the following paragraph was deleted:

"Sf = 100 x Fm/ F, in which "Sf" is the financial score, "Fm" is the lowest price, and "F" the price of the proposal under consideration"

and replaced with:

"Sf = 100 x Fm/F, in which "Sf" is the financial score, "Fm" is the lowest price excluding the Designer's Representative's Remuneration, and "F" the price excluding the Designer's Representative's Remuneration of the proposal under consideration."

B. Sections 4. Technical Proposal Standard Forms

6. In Form FIN-3 Breakdown of Remuneration the following additional item is added:

C. Sections 7. Terms of Reference:

- 4. Team Composition &Qualification Requirements for the Key Experts (and any other requirements which will be used for evaluating the Key Experts under Data Sheet 21.1 of the ITC)

The text has been revised as follows:

"The minimum number of man-months in field required for the assignment is 449. This includes 183 man-months for Key Staff, 256 man-months for Technical Support Staff and 10 manmonths for short-term experts. However the Consultant shall propose the time commitment for each of the key staff in the proposal. The Client expects proposals to be based upon the manmonths estimated by the Client. Consultants offering staff months less than the Client's estimate run the risk of an adverse impact on their technical scores."

The following changes are made to the table of staff:

g) Moldovan Construction Law:

The following text has been deleted:

"The Designer's Representatives shall be required to attend the Site as required by the legislation in force, and a total of 10 man-months shall be included in the Proposal for estimating purposes."

and replaced by:

"The Designer's Representatives shall be required to attend the Site as required by the legislation in force, and a total of 20 man-months (comprising 10 man-months for Designer's Representative for Lot 1 and 10 man-months for Designer's Representative for Lot 2) shall be included in the Proposal for estimating purposes."

and the following text has been added:

"The remuneration rate for the Services of the Designer's Representative is 2,000 (two thousands) Euro. This rate shall be included without modification in the Financial Proposal Form FIN -3. The use of the Designer's Representative's Remuneration is subject to General Conditions of Contract and the Client's prior approval."
