3	<p>Regarding the evaluation criteria of EOIs, “<i>experience of the consultant specific to the assignment</i>”, please specify if the experience of the consultant in other countries than the one of the region is taken into consideration,</p>	<p><i>“Experience of the consultant specific to the assignment” refers to experience gained by the consultant in the successful completion of assignments of similar nature and complexity worldwide, including in the region.</i></p> <p><i>“Experience of the consultant specific to the assignment” should be FIDIC, Supervision, in the Road Sector.</i></p>
