The *Ministry of Transport and Road Infrastructure has applied for* financing from the World Bank toward the cost of the Local Roads Improvement Project and intends to apply part of the proceeds toward payments under the contract for the upgrading and maintenance works on the L376 Road from the junction with the R1 in Cornesti Town to Drujba Village to Radeni Village to the junction with the L405 Road (33.491Km).

"Administratia de Stat a Drumurilor" of the Ministry of Transport and Road Infrastructure now invites sealed bids from eligible bidders for Works for Improvement of Local Road L376 km 0+000 to 33+491 Cornesti to junction with L405 inclusive of maintenance activities such as crack sealing, pothole patching, replacement of defective asphalt, and overlay of existing pavement, clearing of side drains and culverts and reinstatement of road furniture from chainage 0+940 to chainage 13+141 and full pavement construction, construction of private accesses, footpaths where required and road junctions, replacement of failed structures and maintenance of cross drainage structures and all road furniture from chainage 13+141 to chainage 33+491.

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers issued on January 2011 and revised in July 2014* ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
