1	<p>The Consultants should "...provide up to 10 references in similar assignments, undertaken in the previous five (5) years..." Please clarify your understanding of "undertaken in the previous five (5) years...", if it refers to projects "completed" in the previous five (5) years and the starting date of the projects could be earlier than the previous five (5) years.</p> <p>Also, please let us know if references of the ongoing projects will be taken into consideration at the evaluation, taking into account the services provided by the Consultant within the project until the date of the submission of Expression of Interest.</p>	<p><i>Only completed projects in the previous five (5) years, with the starting date of the projects within this period will be taken into consideration.</i></p>
2	<p>Regarding the Company Profile, the Consultant should include the "Name, qualifications and relevant experience of firm's director or manager who will assume overall responsibility for the firm's, association's or joint venture's team coordination, management and output". According to Annex 1, the following information should be included: "relevant managerial capacity of the Team leader / Resident Engineer (CV)".</p> <p>Could you please clarify whether the application should contain CV of firm's director or manager who will assume overall responsibility (including financial, administrative and contract management of the project), or rather the CV of the Team Leader / Resident Engineer who will be in charge of technical activities and technical coordination of team members within the project.</p>	<p><i>For what concerns the Company profile, the Expression of interest shall include the CV of the proposed director or manager, who will assume overall responsibility for the firm's, association's or joint venture's team coordination, management and output, within the "Works Supervision on R1 Bahmut bypass" assignment.</i></p> <p><i>With regard to the Company's experience, the Consultant shall specify for each of the project references included in the Expression of Interest, the names and the functions of the senior professional staff (Project/ Coordinator or Team leader/ Resident Engineer) involved in the projects.</i></p>
3	<p>Regarding company experience, the Consultants should "...provide up to 10 references in similar assignments, undertaken in the previous five (5) years..." Please clarify your understanding of "undertaken in the previous five (5) years...", namely if it refers to activities "completed" in the previous five (5) years (07/2012 – 07/2017), regardless the starting and end dates of the projects.</p>	<p><i>Please refer to Answer 1 above.</i></p>
