Award decision:

Since none of the substantially responsive tenderers have demonstrated that they meet all the qualifying criteria specified in Section III, Evaluation and Qualification Criteria, an affirmative determination for award of the contract, as required by Section 32.2 of the Instructions to Tenderers could not be made.

It has been decided to review the tender process, and after this, recommended the following change to the Qualification Criteria in Clause 2.4.2 (a) of Section III of Part I of the Tender Documents:

"Specific Experience (a) Participation as contractor or management contractor in at least 2 (two) contracts within the last 5 (five) years, each with a value of at least EUR 8 (eight) million excluding VAT, that have been successfully and substantially completed and that are similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology or other characteristics as described in Section VI, Employer's Requirements".

To be replaced by:

"Qualifying Criteria 2.4.2 Specific Experience (a) Participation as contractor or management contractor in at least 1 (one) contract within the last 5 (five) years, with a value of at least EUR 8 (eight) million excluding VAT, that have been successfully and substantially completed and that is similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology or other characteristics as described in Section VI, Employer's Requirements".

It has been also decided that the revision to the Qualification Criteria is communicated to all remaining responsive Tenderers and is published on the SRA and OJEU web-sites, and the stand-still period after award is increased to two weeks under Section II (Tender Data Sheet) Clause 36.1.

The responsive Tenders have been re-examined using the proposed revision to the Qualification Criteria. Page 1 of 2

Following examination, two Tenders were found to have qualified. The tenderer "SK-13 Patstroy JSC" has been found to have submitted the lowest evaluated responsive tender and have demonstrated that it has the necessary capacity and resources to carry out the works.
