## 3. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Please clarify the suitability of granit stone for all kind of hot mix concrete asphalt.

#### **Answer:**

Please refer to the Tender Documents, Part 2 – Requirements – Technical Specification - Chapter 012, Aggregate Filler, Sub-Chapter 012.03 - Aggregate for Bituminous Mixtures

#### 4. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Is there any lowest limit for usage of local personnel?

#### **Answer:**

No limit is specified for the usage of local personnel. Nevertheless the Contractors are encouraged to use local staff.

## 5. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Could the contractor replace retention money (%10 of total amount) with equal amount of bank guarantee?

#### **Answer:**

## 6. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Which of the government departments has authority to give permissions for borrow pits? Does the State Road Administration make any positive affect during the permission?

## **Answer:**

The permissions for borrow pits are required and must be consistent with the Tender Documents, Part 2 - Requirements Technical Specifications, Chapter 016 - Compliance with Environmental

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Are the necessary permits and approved projects, by related authority, for relocation of existing lines and cables ready? Can the contractor commence for those works immediately with the other activities?

#### **Answer:**

Yes.

## 10. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Is there any problematic zone for expropriation other than which has been mentioned in "Appendix to Bid" document?

#### **Answer:**

No.

#### 11. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. Could the contractor work extra hours, night shift and holidays with obeying the local laws?

#### **Answer:**

## 13. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. In BoQ item 30103, it is indicated that recycling stabilization with 4% cement. However TS clause 301.03 limits the cement content from 2 to 4%. Can you please clarify?

#### **Answer:**

The appropriate proportion of the cement will be determined as a result of mixture design and the BoQ indicates maximum proportion of the cement in the mixture.

## 14. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03In TS Clause 305.08, during the design of asphalt mixes, Marshall method is required and this section also refers to SM STB 1033 – 2008. However required tests, their calculations and limitations of SM STB 1033 – 2008 is totally different than Marshall method. (especially for stability testing) Under this condition, which one we need to follow? Marshall or local norms?

## **Answer:**

The standard SM STB 1033 – 2008 should be applied.

## 15. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03What has been referred for "BID REF" at BSF6 Bidder Information Form?

## **Answer:**

Such reference does not exist in issued Tender Documents.

## 16. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03Does the electronic copy of Bid only contain BoQ?

#### **Answer:**

The Electronic copy of the tender shall contain the entire Tender as submitted by the Tenderer in hard copy.

## 17. Question

Please clarify why the Tender Validity Period of 120 days is different from the validity of the Tender Security that shall be 28 days beyond the original validity period of Tender.

## **Answer:**

Tenderers are bound by their tenders for the period specified in the letter of invitation to tender and/or in the tender dossier. Under certain circumstances, the lowest evaluated tenderer whose tender has been determined as being substantially responsive, after receiving the Letter of

Acceptance, may fail to sign the Contract and/or furnish a performance security in accordance with ITT 36 and ITT37 within the Tender Validity Period of 120 days. In this event, the Employer is protected with the Tender Security (the validity period of which is 28 days beyond the original validity period of tender) against the risk of the tenderer's conduct which would warrant the forfeiture of the tenderin accordance with the Sub-Clause 19.6 of ITT.

## 18. Question

In case we are awarded the contract, do we have to establish a local company in Moldova or may operate as a branch?

#### **Answer:**

The foreign company may operate as a branch company. ## 21. Question

Contract RSPSP/W4/04. Regarding the Bill of Quantities – Bill no.300 – Pavement – unit of measure for the item number 30401 and 30402 is "liter". We believe that the correct unit of measure should be "square meter". Please clarify.

#### **Answer:**

The unit is "liter".

## 22. Question

Contract RSPSP/W4/04. Please retransmit all tables lists the formulas corrected amounts as:

- Bill no.500 missing formula in TOTAL (cell F148)
- In the cell of the summary final Grand Total does not add up Bill no. 000 General requirements

#### **Answer:**

The BoQ's excel file has been updated. Please redownload the Tender Documents from the SRA's website.

Contract RSPSP/W4/04. Regarding the BoQ – Bill no. 800 – Engineering Services Item no: 80104 – 500 liniar metre – Arrangement of external lighting (subterranean cable). We did not find the description price for this item. Please give us more details.

#### **Answer:**

#### **Answer:**

Contract RSPSP/W4/04. Regarding the BoQ – Bill no. 800 – Engineering Services Item No: 80201 – Rearangement of communication lines – liniar metre – 3200. In Appendix.Associated Data, pag.86, liniar metre – 1600. Please clarify.

## **Answer:**

This stands for 2 cables in one trench.

## 26. Question

Contract RSPSP/W4/04. Regarding the BoQ – Bill no. 800 – Engineering Services in Appendix. Associated Data, pag. 91 there is a BoQ "M3 existing section km 179+650 – km 192+430", which we not find in Bill no. 800. Please clarify.

#### **Answer:**

This will be addressed in an Amendment to the Tender Documents which will be issued in accordance with ITT 8 [Amendment of Tender Documents].

## 27. Question

Contract RSPSP/W4/04. Regarding Utility Relocation Chapter (electricals, communication, high pressure gas pipelines), for the better assessment of work, please send us more details of execution.

Please refer to the Tender Documents, Part 2 – Requirements – Technical Specification, Chapter 006, Miscellaneous Requirements, Sub-Chapter 006.06, Protection and Diversion of Services.

## 28. Question

Contract RSPSP/W4/04. Regarding the List of Volume – Underground high pressure gas pipeline, Pag. 97 – 98, of "Appendix. Associated Data", art.5 Faily strong waterproof, there are 2 units of measure: m<sup>2</sup> and m<sup>3</sup> with different quantities. Please clarify.

This will be addressed in an Amendment to the Tender Documents which will be issued in accordance with ITT 8 [Amendment of Tender Documents].

## 29. Question

In connection to provision 30 Conversion to a single currency of Section III Evaluation and Qualification Criteria, what should be the source of the exchange rate and what dates should be applied (in case of contracts for general experience)?

#### **Answer:**

Please refer to the TDS 15.1;

In case of contracts for general experience - The Euro foreign exchange reference rates as source for exchange rate and the date of signing of referred contract may be used.

## 30. Question

In reference to Form FIN-1: Financial Situation the financial data should be stated for last five years. Please clarify which years, because during prequalification period it were years 2006 – 2010, and as the Schedule of Supplementary Information only accompanies but not form part of the Tender, which years should be adopted: 2006 – 2010 or 2007 – 2011 (or even 2012 as the year 2012 in our company is settled around June) and should we once again attach financial statements? The same relates to Annual Construction Turnover.

#### **Answer:**

Tenderers should fill in and provide the Form FIN-1: Financial Situation including supporting audited annual accounts for the last five years, namely for 2007, 2008, 2009, 2010 and 2011.

## 31. Question

We understand that when it comes to requirements for Contractor's Personnel, as well as General Construction Experience and Key Construction Experience, we should comply with the requirements stated during prequalification stage, as for example Criteria 2.4.2(a) or (b) are not quoted in the Tender Documents?

## **Answer:**

Please refer to para 4.5 of ITA, Prequalification Document, which states that at the time of submitting their tenders, prequalified tenderers shall update the relevant information used for prequalification to confirm that they continue to comply with the qualification criteria and verify that the information previously provided is still valid and correct.

## 32. Question

Please confirm that we should submit 4 separate sets of documents for 4 lots (or we can submit one set of documentation).

## **Answer:**

Tenderers prequalified for more than one contract should submit separate Tenders for each contract.

#### 33. Ouestion

If there are no changes to the Contractor's Personnel, General Construction Experience, Key Construction Experience and Financial Information from the prequalification stage, we can submit

only statement confirming that there are not changes?

#### **Answer:**

Please refer to the Answer to the Question No.31

## 34. Question

In the event of submitting tender offers for all 4 lots, can we demonstrate the same key construction experience for each lot?

#### **Answer:**

Yes. In such case the lowest responsive tenderer with the same key construction experience for each lot will be awarded only one contract.

BoQ No.000 pos.00402 "Maintain contract office for the whole duration of construction works according to the time of completion stated in Volume I of the tender documents" – given unit is [Lump – Sum], but in Technical Specification point 004.11 for the pos.00402 is [Month]. Please clarify and amend the documentation

#### **Answer:**

## 36. Question

We also ask for information about the class of shrubs which will be planted. Please confirm that the trees (according to TS) are willow and popular.

Please refer to the Tender Documents, Part 2 – Requirements – Technical Specification, Chapter 204 – Shaping and Planting of Slopes and Excavated Surfaces, Sub-Chapter 204.02 – Materials.

## 37. Question

Contracts RSPSP/W4/01, RSPSP/W4/02 and RSPSP/W4/03. BoQ No. 300 in pos.30501 "Wearing course of stone mastic asphalt concrete <u>Thickness 50 mm</u>" but in TS point 305.17 Payment for the position.30501is text "Wearing course of stone mastic asphalt concrete <u>Thickness 40 mm</u>". Please clarify which thickness should be applied.

#### **Answer:**

Please change the unit and give the quantity [m3] in BoQ.

## 51. Question

Contract RSPSP/W4/01. In TS point 105.09. **Construction of Diversion Roads** contains the following text: "Locations where diversion roads are accepted as being necessary are indicated on the drawings." Please indicate where the locations of diversion roads are on the drawings. It is necessary to estimate the cost of diversion road in BoQ pos.10501 "Provide diversion road".

#### **Answer:**

Provisional roads were not included in the plans. Design Team carried out works under the assumption that construction will be carried out on half-width of road.
